Purpose of the contract clauses

By specifying FORS in your procurement contracts with fleet operators, your organisation is protecting and enhancing its reputation and helping to improve transport standards across the UK. Specifying FORS ensures all commercial vehicle operators working on your contracts meet the highest possible environmental, safety and efficiency standards.

To assist both public and private sector organisations that are specifying, or are seeking to specify, FORS Bronze, Silver or Gold, FORS has developed a series of contractual clauses for procurement contracts. The contract clauses include:

- Contract clause FORS Bronze Public sector
- Contract clause FORS Silver Private sector
- Contract clause FORS Silver Public sector
- Contract clause FORS Gold Private sector
- Contract clause FORS Gold Public sector

This document should be read in conjunction with the Specifying FORS in contracts: your guide to a safer, smarter and greener supply chain.

Who should use the contract clauses?

The contract clauses are aimed at the people in organisations who are directly involved or have a professional interest in the decision-making process for their supply chain and are seeking to improve their organisation's overall levels of safety, efficiency and environmental protection. This includes:

- Project leads
- Logistics managers
- Local authorities

XX.2 Where the [Service Provider] operates Delivery and Servicing Vehicles or passenger carrying vehicles to provide the Services, it shall within 90 days of the Contract Commencement Date:

XX.2.1 (unless already registered) register with FORS; and

XX.2.2 (unless already accredited) have attained the standard of Bronze Accreditation (or higher) and shall maintain the standard of Bronze Accreditation by way of an annual independent audit in accordance with the FORS Standard. Alternatively, where the [Service Provider] has attained Silver or Gold Accreditation, the maintenance requirements shall be undertaken in accordance with the periods set out in the FORS Standard.

Self-certification of compliance

XX.3 Where the [Service Provider] operates Delivery and Servicing Vehicles or passenger carrying vehicles to provide the Services, within 90 days of the Commencement Date, the [Service Provider] shall make a written report to the [Authority] detailing its compliance with Clause [XX.2] of this Contract (the "[Self-Certification Report]"). The [Service Provider] shall provide updates of the [Self-Certification Report] to the [Authority] on each six-month anniversary of its submission of the initial [Self-Certification Report].

Obligations of the Service Provider regarding subcontractors

XX.4 The [Service Provider] shall ensure that its sub-contractors who operate Delivery and Servicing Vehicles or passenger carrying vehicles to provide the Services shall comply with the corresponding provisions of this Contract as if those sub-contractors were a party to this Contract.

Failure to comply

XX.5 Without limiting the effect of any other clause of this Contract relating to termination, if the [Service Provider] fails to comply with Clauses [XX.2, XX.3 or XX.4];

XX.1 For the purposes of Clauses [XX.2 to XX.5] (inclusive) of this Contract, the following expressions shall have the following meanings:
